In accordance with the requirements of the Interstate Commerce Act and the rules and regulations of the Federal Energy Regulatory Commission, Saddlehorn Pipeline Company, LLC (“Saddlehorn”) submits for filing the tariff listed below, issued on August 31, 2022 to be effective on October 1, 2022. This tariff is issued by Jake Nolte, Supervisor, Pipeline Tariffs of Magellan Pipeline Company, L.P., operator of Saddlehorn.

F.E.R.C. No. 4.9.0 canceling F.E.R.C. No. 4.8.0, IS22-717-000

F.E.R.C. No. 4.9.0 is issued under the authority of 18 CFR 342.2(b) and contains local uncommitted and committed rates. Items 100 and 110 containing routes and rates from Laramie County Central Delivery Point, Laramie County, WY to the interim points of Cheyenne Junction, WY and Carr, CO are being cancelled for lack of use. Saddlehorn will instead provide through service to Platteville, CO, as provided in new Item 120. Items 120 and 130 in F.E.R.C. No. 4.8.0 have been renumbered to become Items 100 and 110 in F.E.R.C. No. 4.9.0. The committed rates in updated Items 100 and 110 from Laramie County Central Delivery Point, Laramie County, WY and Cheyenne Junction, Laramie County, WY to Cushing have been decreased. New Items 120 and 130 contain new local uncommitted routes and rates and correspond to new committed rates from Laramie County Central Delivery Point, Laramie County, WY and Cheyenne Junction, Laramie County, WY to Platteville, CO. An affidavit indicating that at least one non-affiliated shipper has agreed to these new rates is attached.
