

Advice Letter No. 32

Oil Pipeline Tariff Filing

Dear Mr. Dean:

The accompanying tariff, **Colorado P.U.C. No. 11.9.0**, is issued by Magellan Pipeline Company, L.P. (MPL), in compliance with requirements of Public Utilities Law.

Colorado P.U.C. No. 11.9.0 cancels MPL's Colorado P.U.C. No. 11.8.0. **Colorado P.U.C. No. 11.9.0** contains rules, regulations and rates for the movement of petroleum products on MPL's pipeline system from Denver, Colorado, to Denver International Airport. No changes are proposed to any of the rules and regulations contained in this tariff.

Pursuant to the Federal Energy Regulatory Commission's orders in Docket No. OR10-6-000 issued on December 14, 2011 (137 FERC ¶ 61,222)¹ and Docket No. OR97-13-000 issued on May 18, 1998 (83 FERC ¶ 61,183),² MPL is authorized by the Federal Energy Regulatory Commission to charge market-based rates not subject to the FERC index to delivery points in the Denver, Colorado area. To remain consistent with the increases applied to MPL interstate transportation rates to the Denver area,³ MPL proposes an increase of 2.41 cents to the transportation rate in **Colorado P.U.C. No. 11.9.0** from Denver, Colorado, to Denver International Airport.

This Advice Letter No. 32 and the associated tariff is being issued with a proposed effective date of July 1, 2022. This letter and associated tariff mentioned above have been e-filed with the Colorado Public Utilities Commission. I have sent copies of this tariff to all subscribers.
