No. 160.42.0 is filed under authority of 18 CFR 342.4(b) (market-based) pursuant to the Commission's finding of lack of market power in Opinion No. 391 (68 FERC ¶ 61,136) and Opinion No. 391-A (71 FERC ¶ 61,291). This tariff increases the market-based rates in Item No. 205 for the destinations of Lincoln (Jamaica), (Terra), and (MPL Roca). No other changes have been made to this tariff.
