The accompanying Magellan Pipeline Company, L.P. ("MPL") tariffs, issued on December 1, 2022, to be effective on January 1, 2023, are sent to you for filing in compliance with the requirements of the Interstate Commerce Act and the rules and regulations of the Federal Energy Regulatory Commission. Said tariffs are issued by Jake Nolte, Supervisor, Tariffs, for MPL, and are concurred in by all carriers named therein as participants under the concurrences or authorizations now on file with Carrier.

F.E.R.C. No. 160.42.1 is filed under authority of 18 CFR 341.5 (cancellation of tariffs), 18 CFR 342.3 (indexing), and 18 CFR 342.4(b) (market-based) pursuant to the Commission's finding of lack of market power in Opinion No. 391 (68 FERC ¶ 61,136) and Opinion No. 391-A (71 FERC ¶ 61,291). This tariff contains local and joint rates. This tariff cancels the destinations of Albany, IL, Atchinson (Lincoln Grain), KS, Cushing, OK, Heyworth, IL, Humboldt, KS, Inver Hills (NSP), MN, Lincoln (Jamaica), NE, Lincoln (Terra), NE, Menard, IL, Savage, MN, Shakopee (NSP), MN, St. Bonifacius, MN, Superior, WI, and Wheaton (NSP), WI from all origins for lack of use. In Item 201, the indexed rate from Kansas origins to the Topeka, KS destination is increased to its indexed ceiling level. A schedule showing the ceiling calculation for the local rate is attached hereto. In addition, in Item 205, the market-based rates from Minneapolis origins to the Alexandria, MN, Minneapolis (MPL), MN and St. Paul Park, MN are increased. The listed locations of Duncan, OK, Minneapolis (Koch), MN, and Newport, MN lack the presence of interstate rates and are removed from the tariff. References to other tariffs have been updated to reflect the current tariff numbers where applicable. No other changes have been made to this tariff.

F.E.R.C. No. 164.14.0 is filed under authority of 18 CFR 341.5 (cancellation of tariffs) and contains local rates. Service is being terminated for the local transportation movement to Bettendorf, IA. The rate from Wilmington Junction, IL to Bettendorf, IA is cancelled.

F.E.R.C. No. 165.15.0 contains joint rates. Service is being terminated for the joint transportation movement to Bettendorf, IA. The joint rate from the Manhattan, IL to Bettendorf, IA is cancelled.
