F.E.R.C. No. 10.4.0 contains an increased Contract Rate filed as settlement rate pursuant to Commission Order on Petition for Declaratory Order under OR 19-31-000, issued November 21, 2019. Also, attached is an affidavit stating that all parties who currently use this service have agreed to the rate.

F.E.R.C. No. 2.14.0 contains the local, uncommitted base rate and volume threshold tiers for incentive rates. The incentive rate associated with the second tier from Platteville, CO to Cushing, OK is being increased. The base rate and third tier incentive rate are unchanged.
